SUBMISSION GUIDELINES

- Chapter:
 - The paper shall be in Times New Roman, font size 12, 1.5 line spacing.
 - Main title should be in full capitals, bold and centered with a 12 point font.
 - Sub-titles should be in sentence case, bold and 12 point font.
 - Text should be justified.

CALL FOR CHAPTERS

- Citation/Footnote Format:
 - Please use footnotes rather than endnotes or references.
 - Authors shall use a uniform method of citation..
 - Footnotes should be in Times New Roman, size 10 single line spacing.
 - A margin of 4 centimetres shall be left on all sides of the paper.
 - Page borders, headers, footers shall not be used.
- Abstract:
 - All submissions must contain an abstract of not more than 350 words.
- Originality of Manuscripts:
 - All the contributions should be the original work of the contributors and should not have been submitted for consideration in any other Publication. Any plagiarized work will be out-rightly rejected.

GUIDELINES FOR MANUSCRIPT SUBMISSION

- The title of the Chapter should be followed by Name, Designation, Name of the Organization / University / Institution and Email address of the Author.
- A cover letter with the name(s) of the author(s) and address, designation, institution/affiliation, the title of the manuscript and contact information (email, phone, etc.) is compulsory to submit.

CALL FOR CHAPTERS

- Provide name and details of Co-author, if any.
- The paper should be submitted in MS WORD format.
- The paper must be in a single column layout with margins justified on both sides.
- The length of manuscript should not exceed **3000 - 6000 words** (excluding abstract).
- The submissions received would be reviewed by the panel of Editors to determine whether the Subject matter is within the scope of the Book and assess the quality of the manuscript
- All accepted chapters will be published in Book by an established publishing house of International/National repute and will bear ISBN number.
- Certificate of Publication shall be issued to each author.

MANUSCRIPT PROCESSING/PUBLICATION FEE (AFTER THE ACCEPTANCE OF THE MANUSCRIPT)

Authors are required to pay the manuscript processing/publication fee after manuscript acceptance, and the fee details are outlined below:
